



**What is iCEV’s TIA-approved pre-test and post-test feature?**

iCEV is approved for Option 2 under the Texas TIA framework, allowing districts to use iCEV as a third-party pre-test and post-test to measure student growth. Each district sets its own growth targets based on its specific needs and criteria.

**What are the available opportunities for the TIA-approved pre-test and post-test feature on iCEV?**

The TIA-approved pre-test and post-test feature from iCEV is available for TEKS-aligned courses as well as industry-based certifications administered through the iCEV Testing Platform. The key differences are outlined below.

**The following questions pertain to iCEV’s pre-test and post-test feature for TEKS-aligned courses.**

**Can the pre-test and post-test feature be purchased separately from the iCEV curriculum?**

No, the pre-test and post-test feature is only available as part of the iCEV curriculum and cannot be purchased separately.

**How is the pre-test and post-test feature priced?**

The cost is per student and applies to all students with access to the iCEV curriculum. It is not charged per test attempt. Each student license includes access to both the pre-test and post-test and can be used across multiple courses.

### **Which courses include the pre-test and post-test feature?**

The pre-test and post-test feature is available only for designated iCEV courses and must be used with the exact playlist match for the designated course. To verify eligibility, check the approved course list [here](#). This feature is not available for custom-built courses created from scratch.

### **What happens if an iCEV course is customized by adding or removing lessons?**

If a designated pre-test and post-test course is customized by adding or removing lessons, students will still be assessed on all TEKS covered in the original course structure, including those from any removed lessons.

### **Are the questions aligned to Texas Essential Knowledge & Skills (TEKS)?**

Yes, all questions align with TEKS. The selected TEKS focus on course-specific content to ensure assessments evaluate key concepts and essential skills, rather than general employability skills or broad topics.

### **Are alignment blueprints available?**

Yes, alignment blueprints are provided to outline which TEKS were selected for question alignment and how iCEV lessons align with those TEKS. These blueprints serve as a valuable resource for supporting student growth and instructional planning.

### **How many questions are included in the pre-test and post-test?**

Each test consists of 50 questions. These questions are developed using psychometric principles to ensure reliability, validity, and freedom from bias.

### **How long does it take to complete the test?**

The test typically takes 30–50 minutes.

### **Do the pre-test and post-test have text-to-speech capabilities?**

Yes, text-to-speech is available.

### **Who is responsible for enabling the pre-test and post-test Feature?**

The Org Admin manages this setting in the Organization Settings. They can configure options that allow teachers to conduct pre-tests and post-tests, reset tests, and view results. Enabling these options grants teachers the necessary permissions for managing the tests.



**Can teachers enable pre-tests and post-tests for their students?**

Yes, if Org Admins have enabled this setting, teachers can activate pre-tests and post-tests from their dashboard.

**Are there specific timeframes for administering the tests?**

The district determines the testing schedule, ensuring it aligns with TIA guidelines.

**Can students take the test in multiple sittings?**

No, the test must be completed in a single sitting.

**Are test questions and answers available for review?**

No, to maintain test integrity, questions and answers are never resurfaced.

**What happens if a student is kicked out of the test or closes the browser before submitting?**

The district (not iCEV) has access to a reset option, allowing them to restart the test if a student is unable to complete it due to technical issues.

**Can a test be reset after submission?**

No, a reset is only allowed if the student did not submit the test and no score was recorded due to technical issues (e.g., internet loss, closed browser).

**Can students retake the test after submission?**

No, once successfully submitted, the test cannot be retaken.

**Will students receive a score after submitting the pre-test or post-test?**

No, students will not receive a score after submitting the pre-test or the post-test.

**Will teachers see the final scores of the pre-test and post-test?**

Yes, final scores will be available in reports for teachers, if enabled by the Org Admin.

**Will educators receive detailed reports on student performance?**

Yes, Organizational Administrators will receive comprehensive reports to assess student growth and instructional effectiveness. Teachers can also access these reports if granted permission by the Org Admin. The reports provide performance insights at both the class level, categorized by TEKS standards, and at the individual student level.



Report	Description
Educational Standard by Course	Provides pre-test and pos-test scores as well as percentage difference growth by TEK at the class level, allowing for analysis of trends based on TEKS.
Student Performance by Course	Includes the following for each student, with the ability to compare to the class average:
	- Pre-test score overall
	- Post-test score overall
	- Percentage difference growth overall
	- Percentage growth overall
	- Timestamps (date, time and duration)
	- Pre-test score by TEK
	- Post-test score by TEK
	- Percentage growth by TEK
